**A RESOLUTION OF THE BOARD OF SUPERVISORS OF PINAL COUNTY
CANCELLING THE REGULAR ELECTIONS OF NOVEMBER 8, 2016 FOR CERTAIN
POLITICAL SUBDIVISIONS IN PINAL COUNTY.**

WHEREAS, Pinal County is a regularly constituted and organized County within the State of Arizona; and

WHEREAS, pursuant to A.R.S. § 16-410(A), in any election that is to be held pursuant to title 15 or title 48 of the Arizona Revised Statutes, if the total of the number of persons who file a nomination petition for a candidate and the number of persons who file a nomination paper for a write-in candidate is less than or equal to the number of positions to be filled at the election for which the nomination petition or nomination paper is filed, the county board of supervisors may cancel the election and appoint the person or persons who filed the nomination petition or nomination paper to fill the position for the term of office for which the candidate was nominated; and

WHEREAS, each of the following listed are elections to be held pursuant to either title 15 or title 48 of the Arizona Revised Statutes, for regularly constituted and organized political subdivisions within the State of Arizona and Pinal County; and

WHEREAS, for each of the following listed elections the following person, or persons, have filed a nominating petition for election to the governing board of that particular political subdivision:

WHEREAS, cancellation of said elections would result in substantial savings for the taxpayers of Pinal County by avoiding the numerous costs associated with conducting an election for the position of governing board member in these listed political subdivisions;

NOW THEREFORE BE IT RESOLVED by the County of Pinal as follows:

1. The elections for the positions of governing board member, scheduled for August 30, 2016 is canceled pursuant to the authority granted the Pinal County Board of Supervisors.
