The notification Managers duties include developing and implementing victim notification policies and procedures to ensure statutorily mandated victim notification requirements are met.
Strategic Goals Alignment Description	The County Attorney's office is mandated by statute to provide specific notification to victims of crime as stated in ARS Title 8, Chapter 3, Article 7 and Title 13, Chapter 40. The Pinal County Attorney's Office is committed to ensuring victims' access to justice and an opportunity to participate in the criminal justice system. Furthermore, the PCAO is committed to complying with and enforcing all applicable Federal, State, and Local laws.
Costs and Benefits Description	VRP funds are used to offset costs associated with the statutorily mandated duties of the County Attorney's Office under victims' right laws thereby providing a financial resource to fund effective compliance.
