**A RESOLUTION OF THE BOARD OF SUPERVISORS OF PINAL COUNTY
CANCELLING THE ANNUAL ELECTION OF NOVEMBER 15, 2016 FOR CENTRAL
ARIZONA IRRIGATION & DRAINAGE DISTRICT (“CAIDD”) IN PINAL COUNTY.**

WHEREAS, Pinal County is a regularly constituted and organized County within the State of Arizona; and

WHEREAS, pursuant to A.R.S. § 16-410(A), in any election that is to be held pursuant to title 15 or title 48 of the Arizona Revised Statutes, if the total of the number of persons who file a nomination petition for a candidate and the number of persons who file a nomination paper for a write-in candidate is less than or equal to the number of positions to be filled at the election for which the nomination petition or nomination paper is filed, the county board of supervisors may cancel the election and appoint the person or persons who filed the nomination petition or nomination paper to fill the position for the term of office for which the candidate was nominated; and

WHEREAS, the following listed is an election to be held pursuant to either title 15 or title 48 of the Arizona Revised Statutes, for regularly constituted and organized political subdivisions within the State of Arizona and Pinal County; and

WHEREAS, the following listed is an election for the following person, or persons, have filed a nominating petition for election to the governing board of that particular political subdivision:

CENTRAL ARIZONA IRRIGATION & DRAINAGE DISTRICT

Division 1: Penny E. Malone (3-year term)

Division 2: John P. Donley (3-year term)

Division 3: Rodney Shedd (3-year term),

and are the only persons to have done so, thus rendering each election an uncontested election; and

WHEREAS, cancellation of said election would result in substantial savings for the taxpayers of Pinal County by avoiding the numerous costs associated with conducting an election for the position of governing board member in this listed political subdivision;

NOW THEREFORE BE IT RESOLVED by the County of Pinal as follows:

1. The election for the positions of governing board member, scheduled for November 15, 2016 is canceled pursuant to the authority granted the Pinal County Board of

Supervisors.

2. The following persons are hereby appointed to fill the position of governing board member for a term of three years in the following political subdivisions in Pinal County:

CENTRAL ARIZONA IRRIGATION & DRAINAGE DISTRICT

Division 1: Penny E. Malone (3-year term)

Division 2: John P. Donley (3-year term)

Division 3: Rodney Shedd (3-year term),

3. If no nomination petitions for a candidate and no nomination papers for a write-in candidate have been filed to fill the position for which the election was being held, the position is deemed vacant and shall be filled in accordance with laws governing the filling of those vacancies.

4. This action is taken pursuant to the authority granted the Pinal County Board of Supervisors under A.R.S. § 16-410(A).
